

COOKIE POLICY

information text regarding the cookies used by our website

This text has been prepared by the data controller,

, in accordance with the Article 10 of the “Personal Data Protection Law” numbered 6698 and
the “Communique on Principles and Procedures to Be Followed in Fulfilment of The Obligation
to Inform”.

The aim of this Cookie Policy document is to provide information to you about processing
personal data through the cookies of our website which are placed into your device, and
regarding purposes, types of cookies, their legal basis and your rights.

Our website uses first party session and persistent cookies that are strictly and solely necessary
to provide services.

Cookie Types

Cookies according to the duration: Session cookies are used for the continuity of the session.
When the user closes his/her browser, these session cookies expire. However, persistent cookies
do not expire even the browser is closed by the user and they expire when they reach a specified
date or after a certain time. In that regard, session cookies and persistent cookies are used on our
website.

First Party and Third-Party cookies: First party cookies are directly placed by the website i.e.
address shown in the browser’s address bar- visited by the user. However, third party cookies are
placed by another domain other than the website visited by the user. In this framework, only first
party cookies are used on our website.

Cookie types according to usage purposes: Cookies can be used in accordance with their usage
purposes such as strictly necessary, functional or advertising/marketing. In that regard, our
website uses strictly necessary cookies to enable the information society services explicitly
requested by you. In that regard,

- A) **cookiesession1** is used for the purpose of web site security to check whether the requests to
website are authentic. It is a first party persistent cookie and the retention period is one year,
- B) **ASP.NET SessionId** is a first party session cookie used for specifying the language in which
the user prefers to view the website
- C) **cookiepolicy status** is a first party persistent cookie used for confirming that this Cookie
Policy was read by the user and the retention period is one year.

Your personal data are processed by associating with your IP data and your personal data are not
transferred to other data controllers.

Legal Basis for Personal Data Processing Your personal data are processed through cookies, based
on Article 5/2(f) of the Personal Data Protection Law which stipulates that “Processing of data is
necessary for the legitimate interests pursued by the data controller, provided that this processing
shall not violate the fundamental rights and freedoms of the data subject.” Requests of the Data
Subjects Data subjects can convey their requests regarding the personal data processed through the
